Increase Operational Capacity

- ARSL Office is open and available to members 50 hours per week (7 am - 5 pm PT, M-F).
- ARSL Supporters Alliance initiative allows businesses to sponsor our organization year-round. Thorndike Press joined the Supporters Alliance this year at the Ally+ tier!
- More than 250 volunteers gave over 1,000 hours of their time and talents across our Board, Regional Forums, Committees, and as in-person Conference Volunteers in 2024.
- As recommended in 2023, ARSL established an investments portfolio this year to diversify operational revenue.
- IMLS awarded ARSL funding for a second pilot of the ARSL Leadership Institute. 30 applicants were accepted into the 2024-25 cohort.
- The ARSL Office expanded to include two new staff roles, the Fund Development Coordinator and Community Relations Coordinator.

Increase Member Support

- The ARSL Advocacy Center steadily ganed traction throughout 2024. Through this tool the Advocacy Committee is able to connect directly with library workers seeking assistance with emerging community advocacy needs.
- Through our collaboration with generous funding private partners, ARSL has distributed more than \$2.0M in cash grants to small and rural libraries nationwide.

Increase ARSL Visibility

- ARSL collaborates directly with organizations like the Urban Libraries Council (ULC), Chief Officers of State Library Agencies (COSLA), and the Institute for Museum and Library Services (IMLS) to ensure our community's needs and perspectives are well-represented in broader national conversations around library service
- ARSL staff and board members represented ARSL at national and regional events across the continental US.
- The new Community Relations Coordinator will allow ARSL to expand awareness through social media.

Expand Organizational Infrastructure

- ARSL has nine professional networking groups, facilitated by ARSL members, that meet regularly to provide a space for the important connections and conversations that are the heart of ARSL.
- Regional Focus Groups have generated a number of actionable ideas for our committees, including the development of Benefit Guides to help members make the most of their memberships.
- Governance Committee has completed a first review of all existing policies that were adopted more than 5 years ago, and updated the Scholarship Policy.
- Partnership Committee implemented a formal Partnership Request process to make establishing, tracking, and following through on our commitments to our partner organizations more efficient.



Adopted in 2024, ARSL's strategic plan is a living document that serves as a roadmap that the staff, board, and membership use to keep ARSL's work focused and effective. ARSL reviews our strategic goals regularly to be sure they align with the evolving needs of the organization and its constituents. Our current plan will guide ARSL into 2027 and beyond.


Membership Joins

SUPPORTING OUR COMMUNITY



Sustainable & Resilient New England Libraries Grant

- In 2024, ARSL provided a record amount of grant funding for rural & small libraries in New England, awarding a total of **\$590,000 to 49 libraries**.
- ARSL published the <u>2022-2024 Sustainable & Resilient New England Libraries Grant Impact Report,</u> showcasing the transformative effect these grants have had on local communities. **Over 1 million people** have been impacted, with **338 projects funded across 136 libraries**, impacting approximately **20% of all** rural libraries in New England.

IMLS Leadership Institute

- 2024 saw the beginning of the second Leadership Institute, with 30 new cohort members accepted. This
 program is focused on elevating staff in rural & small libraries to step confidently into leadership
 roles in their libraries and beyond.
- Beginning in June, cohort members met monthly for directed classes and meetings with their mentors.
- In September 2024, cohort members attended the 2024 ARSL Conference, spending two days at the Leadership Institute Retreat, followed by a full ARSL Conference experience with social meet-ups.

Hurricane Relief: John Henry Eldred Jr. Foundation

- Following Hurricanes Helene and Milton, ARSL partnered with the John Henry Eldred Jr. Foundation to identify **10 rural libraries in North Carolina and Georgia** most in need of support.
- **\$130,000** in grant funds went directly to library workers on the ground to restore their collections and enable them to continue serving their communities during recovery.

PROFESSIONAL DEVELOPMENT



ARSL TRAIN Training, Roundtables, and Informational Networking

- ARSL's Continuing Education Committee led 12 TRAINs in 2024, including 8 workshops and 4
 roundtables. Topics ranged from Community Asset Mapping to Empowering Library Workers to be
 Advocates to Social Media Tips & Tricks
- A total of **291 library professionals attended** these TRAIN sessions. *Roundtables were restricted to ARSL members, while workshops were available to members and nonmembers for a nominal fee.*

Professional Networking Groups

- Our **9 Professional Networking groups**, facilitated by ARSL members, that meet regularly to provide a space for the important connections and conversations that are the heart of ARSL.
- These groups focus on topics and groups such as Readers' Advisory, Solo-ish Librarians, and
 Neurodivergent Library Workers. Most are open only to ARSL members, but several are open to
 nonmembers as well, to provide important spaces for all rural & small library workers to meet and share
 knowledge.
- In 2024, these nine groups met 51 times, with a total of 503 total participants.

Professional Resource Discussion Group

- The Continuing Education Committee led the spring 2024 Professional Resource Discussion Group, "Relationships in the Workplace."
- 32 people attended this informal, member-only discussion.

Regional Forums


Over 100 participants joined the 16 quarterly Regional Forums (West, South, Midwest, Northeast).


Every pandemic-era conference (2020-2023) has been larger than our largest pre-pandemic conference (Burlington, 2019)
